The organization has an atypical gender composition, as for organizations working in the anti-corruption field.



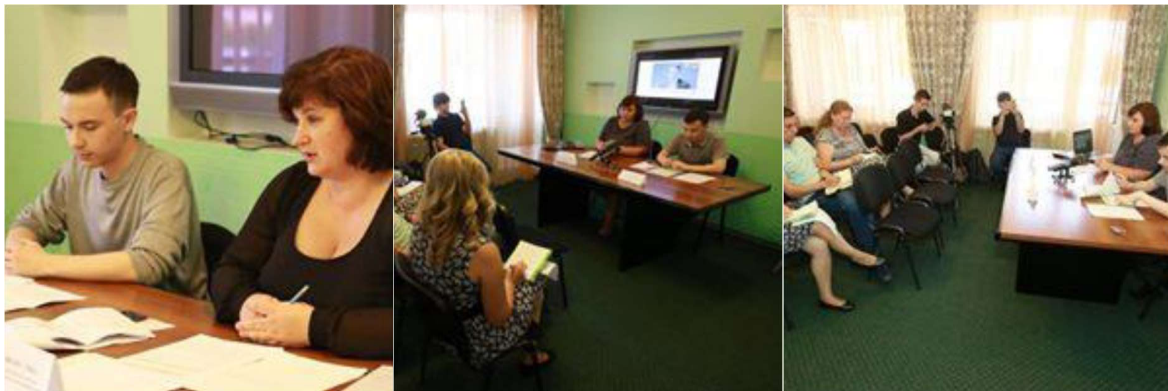

The analysis of draft resolutions of the sessions taken by local councils.

We prepare analysis of draft resolutions and handle it to the deputies before each session of the Kremenchuk City Council and Poltava Regional Council. Within the reported year we extended the mentioned activity and covered Kremenchuk Region Council, Hlobyno Town Council and Hlobyno Region Council. The analysis are freely available on the organization's page in the social network of Facebook. We managed to distribute 9 sets of booklets among the deputies of the Kremenchuk City Council, 5 sets among the deputies of Poltava Regional Council and 5 sets among the deputies of the Horyshni Plavni Town Council and Hlobyno Town Council.

We hope that the deputies will use our intellectual product confidently.



Interactive activities.

Anti-corruption training were focused on developing of skills for working with open data sources. In general, **4 trainings** and **3 workshops** were conducted.



We send our thanks to TOV You Control and Institute for War & Peace Reporting (IWPR) for the provided training materials.

6 meetings with famous public figures of Ukraine were arranged and conducted within the reported year. Kremenchuk Anti-Corruption Center invited Oleksandr Solontai, Dmytro Drobot, Dmytro Bulakh, Erhii Pernykoza, Oleksii Severyn, for public meetings in Kremenchuk.



There were **meetings with famous lawyers**, such as Hennadii Druzdenko, Andrii Osypov - people who make history of modern Ukraine. Their interactions with students of Kremenchuk and public representatives impressed the audience.



Kremenchuk Anti-Corruption Center on TV.

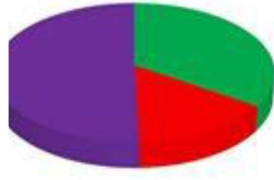
In the close cooperation with “Hromads’ke TV of Kremenchuk” 6 TV shows of “Kremen.Antikor” were launched:

- What is ProZorro and how can you use it?;
- How do the Kremenchuk parks feel and why are they getting smaller?;
- What is transparency of the authorities and how to increase it?

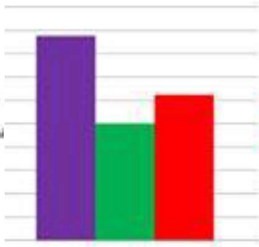


Social surveys were conducted in order to study the attitude of the Kremenchuk residents towards the corruption. Our team members and volunteers questioned **600 residents**. The results of the survey can be found at the Facebook page of the organization.

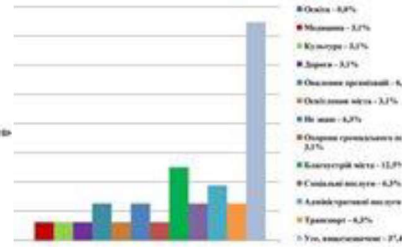


Так - 34,5%

Важко відповісти - 50,5%

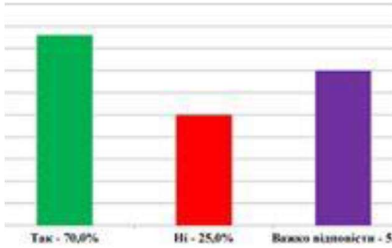


Так - 43,8%

Our **own investigations** were conducted to get the answers for the questions: what hinders the repair of the roof on the building in the city center; why the general plan of the city, where budget millions are allocated, is being trampled on; how do the organisations lured by city authorities work? How can construction at city stops be implemented without permitting documents; We handed some materials to law enforcement agencies.

Monitoring of public procurement allows residents of Kremenchuk to understand how and for what purposes taxpayers' money is spent: here you can find sakura saplings for 16,544 UAH, blueash for 2400 UAH, price of concerts for the city day in all parks (which, by the way, were not conducted), the construction of playgrounds, the provision of legal services to the schools and parks of Kremenchuk, the dubious tender for the purchase of gas by Kremenchuts'ke Komunal'ne Avtotransportne Pidpriemstvo, the purchase of security services by the city authorities and much more. In total, **26 tenders** were analyzed during the year.
